Ukraine Visa Scheme - out of Immigration Rules.

- <u>Ukraine Family Scheme</u> if you have family who are settled in the UK, you
 may be able to apply to the Ukraine Family Scheme
- Homes for Ukraine if you want to be sponsored by a UK household for 6 months, you may be able to apply to the Homes for Ukraine scheme
- <u>Ukraine Extension Scheme</u> you can apply for this scheme if one of the following is true:
 - you held permission to be in the UK on or between 18 March 2022 and 16
 November 2023 the permission does not need to cover the whole period
 - you previously held permission to be in the UK and that permission expired on or after 1 January 2022

Visa expiry dates, features, and restrictions

- ▶ BRP with an expiry date of 31 December 2024.
- ► This is the date that the Home Office plans to transition everyone off physical permits and onto a digital status instead
- Someone granted permission beyond that date will still be able to remain for the full three years.
- ► They will just prove their status using the new digital status system after 2024.
- In other words, the expiry date of the residence permit is not necessarily the expiry date of your immigration permission.

Possibilities of switching to alternative visas.

- ► The visas under the Scheme allow the respective holders to live and work in the UK for three years.
- ▶ The visa route, however, does not lead to settlement!!!
- At the moment, it is not possible to extend your stay under the Ukraine Scheme visas, although the Home Office may change this in the future.
- If you are looking to continue living in the UK past the expiry date of your Ukraine Scheme visa, the current position is that you will need to apply to switch into another visa category.
- The type of visa that will be most suitable for you will depend on your personal circumstances at the time of application.

Immigration routes of switching to alternative visa

- ▶ Skilled Worker visa is a work permit which leads to settlement in the UK after 5 years.
- ▶ You will need an offer of employment from an employer who has Sponsorship license.
- ► A role which meets the minimum skill, salary requirements.
- ▶ The English language requirement is the main issue of Skilled Worker visa.
- Alternatively, you may be able to apply for a family visa if
 - you have a partner or family member in the UK with Pre-Settled or Settled Status under the EU Settlement Scheme,
 - Indefinite Leave to Remain
 - or British citizenship.

Immigration routes of switching to alternative visa

- Big opportunities of Business Visas

- > Self-Sponsorship visa. Register your own company and organise your own business.
- > For young generations student visa.
- > For adult and disabled people humanitarian protection.
- For middle age Ukrainians have to learn for a new qualification, other professions.

Necessary actions Crafting an effective immigration strategy

- ► The type of visa that will be most suitable for you will depend on
 - ▶ Your personal circumstances at the time of application.
 - ► Your personal skills, knowledges, abilities
 - ► English language knowledge
 - ► Your experience
 - Your education
 - ► Your adaptation in the UK

Shortage Occupation list of the UK

Occupation code	Job types included on the shortage occupations list	Areas of the UK where there is a shortage	Annual salary (80% of going rate)
1181	Health services and public health managers and directors - all jobs	England, Scotland, Wales, Northern Ireland	80% of going rate: £33,040 (£16.94 per hour)
1242	Residential, day and domiciliary care managers and proprietors - all jobs	England, Scotland, Wales, Northern Ireland	80% of going rate: £22,640 (£11.61 per hour)

Identifying high-demand professions in the UK

There's a different list of shortage occupations if you do not work in healthcare or education.

Occupation code	Job types included on the shortage occupations list	Areas of the UK where there is a shortage
2211	Medical practitioners - all jobs	England, Scotland, Wales, Northern Ireland
2212	Psychologists - all jobs	England, Scotland, Wales, Northern Ireland
2314	Secondary education teaching professionals - only teachers in maths, physics, science (where an element of physics will be taught), computer science and modern foreign languages	
2314	Secondary education teaching professionals - only teachers in Gaelic	Scotland only
